Being a 191.14 acre tract of land out of the Jeremiah Tinnan Survey, Abstract No. 45, Robertson County, Texas, and being out of that certain called 286.343 acre tract described in a deed to John H. Meadors and Janice Meadors as Trustees of the John H. Meadors and Janice Meadors Revocable Living Trust, recorded in Volume 1062, Page 723 of the Official Records of Robertson County, Texas;

BEGINNING at a 1/2 inch iron rod with pink cap set in the south line of the above mentioned 286.343 acre tract, located on the north line of Old Spanish Road for the southwest corner of this;

THENCE departing said road across said 286.343 acre tract and generally along a fence line the following courses and distances:

N 36°31'20" W a distance of 794.68 feet to a 60d nail set in the base of a 16 inch post oak tree for an angle point of this;
N 46°19'16" W a distance of 804.53 feet to a 60d nail set in the base of a 18 inch post oak tree for an angle point of this;
N 31°04'58" W a distance of 16.12 feet to a 60d nail set in the base of a 18 inch post oak tree for an angle point of this;
N 19°14'34" W a distance of 116.38 feet to a 60d nail set in the base of a 24 inch post oak tree for an angle point of this;
N 22°23'28" W a distance of 563.56 feet to a 1/2 inch iron rod with pink cap set at a corner post located on the north line of said 286.343 acre tract, being the south line of that certain called 1922.801 acre tract to Senator Ranch, (405/559), for the northwest corner of this;

THENCE along the north line of said 286.343 acre tract, common boundary with said 1922.801 acre tract, and along a fence line the following courses and distances:

N 58°45'40" E a distance of 111.89 feet to a 1/2 inch iron rod found at a corner post for an interior corner of this;
N 34°30'06" W a distance of 89.45 feet to a 1/2 inch iron rod set at a fence corner for an exterior corner of this;
N 56°50'37" E a distance of 553.74 feet to a 60d nail set in the base of a 28 inch post oak tree for an angle point of this;
N 56°46'30" E a distance of 402.12 feet to a 60d nail set in the base of a 18 inch post oak tree for an angle point of this;

S 15°02'27" E a distance of 29.46 feet to a t-post found for an angle point of this;
S 02°21'36" W a distance of 69.96 feet to a 60d nail set in the base of a 18 inch twin post oak tree for an angle point of this;
S 12°39'39" W a distance of 340.88 feet to a 60d nail set in the base of a 8 inch water oak tree for an angle point of this;
S 10°45'53" E a distance of 230.24 feet to a 60d nail set in the base of a 24 inch pecan tree for an angle point of this;
S 28°23'46" W a distance of 54.62 feet to a 60d nail set in the base of a 48 inch post oak tree for an angle point of this;
S 04°05'15" W a distance of 56.91 feet to a 60d nail set in the base of a 20 inch twin post oak tree for an angle point of this;
S 13°29'14" W a distance of 105.93 feet to a 60d nail set in the base of a 24 inch dead oak tree for an angle point of this;
S 46°38'27" W a distance of 349.60 feet to a 60d nail set in the base of a 36 inch post oak tree for an angle point of this;
S 00°14'29" W a distance of 103.25 feet to a 1/2 inch iron rod with pink cap set at the base of a 14 inch post oak tree found at the southeast corner of said 286.343 acre tract, same being a southwesterly corner of said 1922.801 acre tract, located on the north line of Old Spanish Road for the southwest corner of this;

THENCE along the south line of said 286.343 acre tract, common boundary with said road, and along a fence line the following courses and distances:

S 43°28'29" W a distance of 68.92 feet to a 12 inch elm tree for an angle point of this;
S 65°23'16" W a distance of 934.81 feet to a 1/2 inch iron rod with pink cap set for an angle point of this;
With a curve to the left having a radius of 2856.36 feet, an arc length of 319.50 feet, a chord bearing of S 62°11'00" W, and a chord length of 319.33 feet to a 1/2 inch iron rod with pink cap set for an angle point of this;




and S 58°58'32" W a distance of 1393.92 feet to the **POINT OF BEGINNING**, in all containing **191.14** acres of land.

This survey was conducted using Global Positioning System (GPS) data, therefore all bearings are based off of True North.
